**Subject:** Constitution of District level committee to discourage / prevent un- authorised wiring by non - licensed persons - Constitution of Committee in Pathanamthitta District - Orders Issued.

**Order No.D1-2459/2015/CEI dated 17/03/2016**

As per GO read 1<sup>st</sup> & 2<sup>nd</sup> above ,Government have issued orders to constitute a District Level Committee to discourage / prevent un - authorized wiring by non - licensed persons . The Chief Electrical Inspector is authorized to constitute the committee in all districts. As per the reference read 4<sup>th</sup> & 5<sup>th</sup> above, various associations had submitted the list of the the representatives of the Non Official Members The Chief Electrical Inspector has considered the suggestions and the District Level Committee to discourage /prevent un-authorized wiring by non-licensed persons in Pathanamthitta district is hereby constituted as under with the following conditions:-

- (i) The tenure of the committee shall be two years
- (ii) The meeting shall be convened quarterly and the minutes to be submitted to the Chief Electrical Inspector for appropriate action
- (iii) The quorum for the meeting shall be six members ( Three from official members and Three from non official members)
- (iv) The Chief Electrical Inspector shall be the Appellate authority with regard to the actions of the committee
- (v) All documents relating to the functions of the district level committee shall be maintained by the convenor.
- (vi) The decision of the majority of the members of the committee shall prevail, and in the event of a tie, the Chairman is empowered to exercise a casting vote also.
- (vii) A member may resign during the tenure by giving one month notice in writing
